### **Notes to the accounts**

Treasurer's report for the period January 1, 2016 to December 31 2016

#### **1. Accounting policies**

These accounts have been prepared from records maintained by the Secretary and other officers of the foundation. The accounts are presented in Australian Dollars only.

#### **2. Funds in transit**

The balance sheet at December 31, 2015-2014 (2016: no balance) includes the balance of an account that includes funds in transit.

#### **3. Trademark**

The foundation owns the Trademark for the Firebird SQL database product. This is shown in the accounts at a nominal value of AUD 1 \$, in order to state its ownership in the financial records of the foundation.

#### **4. Internet Domain Names**

The foundation owns the Internet domain names. This is shown in the accounts at a nominal value of AUD 100 \$.

#### **5. Currency fluctuation**

The financial reports are required to be stated in Australian dollars for legal reasons. The records of account are kept in the currencies of the bank accounts into which deposits are made and from which drawings are taken.

Until October 2016, grant allocations were made in US dollars. From October 2016, as a stringency measure, the allocations were changed to Australian dollars using the same numbers, thus reducing all grants by approximately 25 per cent.

Most grant payments are paid in US dollar or Euro from bank accounts that are held in Australian dollars, US dollars and UK pounds.

#### **6. Documentation project**

Monies collected on behalf of the project to translate the Russian text of the Firebird 2.5 Language Reference into English and to edit and convert it to DocBook format were paid out against invoices received. The sum 61 \$ AUD remains earmarked for future documentation expenses.

#### **7. Balance sheet and 2015 results**

I have presented a revised balance sheet and results for the year 2015 in order to correct the exchange rate used on 31-12-2015 when converting bank balances. The only changes relate to the conversion of bank balances to 31-12-2015.
